

“ be, into effect ; and that such Order being registered in the Registry of the Diocese as directed by the hereinbefore in part recited Act shall come into operation and shall be forthwith binding on all persons whatsoever notwithstanding such vacancy or vacancies.”

And whereas the Right Reverend John, Lord Bishop of St. Davids, hath represented in a writing dated the sixteenth day of March, one thousand nine hundred and ten, to the Right Honourable and Most Reverend Randall Thomas Lord Archbishop of Canterbury as follows :—

“ I The Right Reverend John Lord Bishop of Saint Davids in pursuance of the twenty-sixth section of the Pluralities Act 1838 and the sixth section of the Church Building Act 1839 do hereby represent to your Grace that there is in the County of Cardigan and my Diocese of Saint Davids the Vicarage of Llanddewi Aberarth with the Perpetual Curacy of St. Alban Tyglyn annexed (hereinafter referred to as ‘ the Benefice of Llanddewi Aberarth with St. Alban Tyglyn ’) constituting together one Benefice and being a distinct and separate civil parish defined by well known metes and bounds and having a population that by the census of 1901 amounted to 1,214.

“ That there is also in the said County of Cardigan and my Diocese of Saint Davids the Perpetual Curacy of Henfynyw (hereinafter referred to as ‘ the Benefice of Henfynyw ’) which is also a distinct and separate civil parish defined by well known metes and bounds adjoining the said Benefice of Llanddewi Aberarth with St. Alban Tyglyn and having a population that by the census of 1901 amounted to 886.

“ That the Benefice of Llanddewi Aberarth with St. Alban Tyglyn is now vacant and has a vicarage House or Residence which will continue to be the Vicarage House or Residence of such benefice and that the Benefice of Henfynyw is now held by the Reverend Evan Evans and has also a Vicarage House or Residence which will also continue to be the Vicarage House or Residence of that Benefice.

“ That the Patronage of the Benefice of Llanddewi Aberarth with St. Alban Tyglyn as well as of the Benefice of Henfynyw is vested in me by virtue of my Bishopric.

“ That the net annual value of the said Benefice of Llanddewi Aberarth with St. Alban Tyglyn is £313 or thereabouts and of the said Benefice of Henfynyw £258 or thereabouts.

“ That the emoluments of the said Benefice of Llanddewi Aberarth with St. Alban Tyglyn include (with other Tithe Rentcharge) certain Tithe Rentcharge commuted at £29 16s. 10d. the particulars of which are shown in the Schedule annexed to the scheme hereinafter referred to and (with other capital sums held by the Governors of Queen Anne’s Bounty) a capital sum of £2,427 4s. 7d. held by the said Governors and producing an annual income of £72 16s. 4d.

“ That the Glebe lands Tithes Rents Rentcharges Stipends Fees and other emoluments of the Vicarage or Perpetual Curacy of Llanddewi Aberarth are subject to a mortgage for the term of 35 years (since extended by 10 years) created by an Indenture dated the thirtieth day of November, one thousand eight hundred and seventy-five and made between the Reverend Henry Morgan (since deceased) of the one part and the said Governors of the other part for securing the capital sum of £350 of which £47 6s. 8d. only now

remains owing and is repayable by annual instalments of £5 18s. 4d. with interest thereon at the rate of £4 per centum per annum.

“ That it appears to me that the portion of the Parish of Llanddewi Aberarth which is comprised within the limits of the Urban District of Aberayron in the parish of Llanddewi Aberarth which is contiguous to the parish of Henfynyw more particularly described in the Scheme appended hereto and which has a present population of about 767 and an area of 220 acres or thereabouts may under the provisions of the Acts of Parliament before cited be advantageously separated from the said parish of Llanddewi Aberarth and annexed to and become part of the said Parish of Henfynyw.

“ That it is proposed that the said sum of £29 16s. 10d. commuted Tithe Rentcharge should be assigned and attached to the said Benefice of Henfynyw together with a sum of £1,433 6s. 8d. part of the said sum of £2,427 4s. 7d. and should form part of the endowments of the said Benefice of Henfynyw.

“ That it does not appear that any of the Inhabitants of the portion of the parish of Llanddewi Aberarth so proposed to be separated from that parish have any right by Faculty or otherwise to the exclusive use of any of the pews or sittings in the said Parish of Llanddewi Aberarth.

“ That pursuant to the direction contained in the twenty-sixth section of the first mentioned Act of Parliament I the said Lord Bishop have drawn up a scheme in writing appended to this Representation describing the mode in which it appears to me that the alterations above proposed may be best effected and how the changes consequent on such alteration in respect to Ecclesiastical Jurisdiction Glebe lands Tithes Rentcharges and other Ecclesiastical dues rates and payments and in respect to the Patronage and rights to pews may be made with Justice to all persons interested.

“ And I do submit the same to your Grace together with the consents in writing of me John Lord Bishop as aforesaid the Patron by virtue of my said Bishopric of both the said Benefices of Llanddewi Aberarth with St. Alban Tyglyn and Henfynyw and of the Reverend Evan Evans Perpetual Curate of Henfynyw that your Grace may if on full consideration and enquiry you shall be satisfied with the said Scheme certify the same and such Consents to His Majesty in Council.”

And whereas the said Scheme drawn up by the said Bishop and the Consents referred to in the said Representation are as follows :—

“ Scheme.

“ It is proposed to separate from the parish of Llanddewi Aberarth in the County of Cardigan all that portion which is comprised within the limits of the Urban District of Aberayron in the parish of Llanddewi Aberarth and is more particularly delineated and described in the Map or Plan attached hereto being thereon coloured pink and containing 220 acres or thereabouts and to unite the same to the said adjoining benefice of Henfynyw in the said County of Cardigan so that it may become hereafter for Ecclesiastical purposes a part of such benefice of Henfynyw of which the Parish Church for the time being of the said benefice of Henfynyw shall be the Parish Church.

“ That the said Benefice of Henfynyw so enlarged shall be subject to the same Ecclesiastical Jurisdiction as the said benefice was subject to before being so enlarged.
