

"That the said benefices of Llanddewi Aberarth with St. Alban Tyglyn and Henfynyw shall respectively retain all the emoluments to which they are now respectively entitled except that the emoluments and fees mentioned in the succeeding paragraphs of this Scheme shall be transferred as is thereby directed.

"That the sum of £29 16s. 10d. commuted Tithe Rentcharge described in the schedule hereunder written and charged chiefly upon and issuing out of the lands in that portion of the said parish of Llanddewi Aberarth so to be separated and also on other lands shall be assigned to and attached to the benefice of Henfynyw and a capital sum of £1,433 6s. 8d. part of the sum of £2,427 4s. 7d. held by the Governors of Queen Anne's Bounty shall henceforth cease to be part of the endowment of the said Benefice of Llanddewi Aberarth with St. Alban Tyglyn and shall belong to and become part of the endowment of the said Benefice of Henfynyw.

"That the Benefice of Llanddewi Aberarth with St. Alban Tyglyn and the Tithe Rentcharge and other emoluments of the same Benefice shall be deemed to be liable to the payment of the said mortgage debt of £47 6s. 8d. and the interest thereon.

"That Marriages in respect of the Inhabitants of the said portion of the parish of Llanddewi Aberarth so to be separated from that parish and united to the said parish of Henfynyw shall hereafter be performed in the Parish Church of Henfynyw or Holy Trinity Church Aberayron or in any other Church or Chapel of Ease belonging to the said Benefice of Henfynyw wherein the same may be lawfully solemnized and that the fees for all such marriages usually payable to the Incumbent of a benefice shall belong to the Incumbent of the said Benefice of Henfynyw.

"That Baptisms Churchings and Burials in respect of the Inhabitants of the said portion of the parish of Llanddewi Aberarth so to be separated from that parish and united to the said parish of Henfynyw shall hereafter be performed in the parish Church of Henfynyw or in any other Church or Chapel of Ease belonging to the said Benefice of Henfynyw and duly licensed for Divine Service and that the fees for all such offices in relation thereto usually payable to the Incumbent of a Benefice shall belong and be paid to the Incumbent of the said Benefice of Henfynyw.

"That the Incumbent of the said Benefice of Henfynyw shall also have cure of Souls within the limits of the said portion so to be united to such Benefice as part of his Benefice.

"That no change shall be made in the Right of Patronage or Presentation to either of the said Benefices.

"That the Inhabitants of the said portion of the Benefice of Llanddewi Aberarth with St. Alban Tyglyn so to be separated therefrom and united to the Benefice of Henfynyw shall be exonerated from all liability (if any exists) to repair the Parish Church of Llanddewi Aberarth or any other Church or Chapel now or hereafter to be erected belonging to the said Benefice of Llanddewi Aberarth and become subject to a like liability (if it exists) in respect of the Church of the parish of Henfynyw and such inhabitants of such separated portion shall be entitled to accommodation in the Parish Church of Henfynyw but shall cease to be entitled to accommodation in the Parish Church of Llanddewi Aberarth.
