Whereas by section 54 of the Patents and Designs Act, 1907, it is provided *inter alia* as follows :—

Before a delivery on sale of any articles to which a registered design has been applied, the proprietor shall cause each such article to be marked with the prescribed mark denoting that the design is registered, but on representation made to the Board of Trade by or on behalf of any trade or industry that in the interests of that trade or industry it is expedient to dispense with or modify any of the requirements of the section as to marking, the said Board may by Rule dispense with or modify such requirements as regards such class or description of articles :

And whereas by section 93 it is provided *inter alia* that "prescribed" means prescribed by General Rules under this Act.

And whereas by Rule 68 of the Designs Rules, 1908, it is provided as follows :—

Before delivery on sale of any article to which a registered design has been applied, the proprietor of such design shall cause each such article to be marked with the word

Registered, or with the abbreviation Regd., or with the abbreviation Rd., as he may choose.

And whereas the Manchester Chamber of Commerce has made representations to the Board of Trade that in the interests of the Calico Printing Industry it is expedient that a Rule should be made dispensing with the provisions of Rule 68, so far as regards printed cotton piece goods, except handkerchiefs :

Now, therefore, the Board of Trade give notice that they will be prepared to consider any objections to the making of a Rule dispensing with the provision of Rule 68 so far as regards *printed cotton piece* goods except handkerchiefs, provided such objections are received by them in writing with the name and address of the objector not later than the 31st day of October next.

The Board of Trade have received, through the Secretary of State for Foreign Affairs, the following translations of two Notices, dated the 18th and 19th July respectively, issued by the Swedish Board of Trade.

(1) In compliance with the Royal Order in Council of June 16th, 1905, the Board of Trade declare the government and the town of St. Petersburg; in Russia, infected with cholera.

In accordance with the notices issued, the following places are considered as infected :

With plague :

Egypt; Rio de Janeiro in Brazil; Peru; Valparaiso, Antofagasta and Pisagua in Chile; the provinces of Hedschas and Yemen in Arabia; the Ural and Transcaspian districts in Asia; Afghanistan; the ports of Schat-el-Arab; British East India; Rangoon in British Burma; Manila on Luzon; the island of Formosa; Hanoi in Tonkin; Amoy in China; Kobe and Osaka in Japan; Sydney, Perth, Fremantle, and Geraldton in Australia; and

With cholera :

The governments St. Petersburg, Kiew, Jekaterinoslav, Charkow, Baku, Taurida, Kher-son, the district Don Cossacks, the Kouban territory, and the towns of St. Petersburg and Odessa, in Russia; the ports of the Red Sea; the ports of British East India; Cochinchina; Tonkin; China and Morocco.

(2) The Royal Board of Trade hereby make known, that the station of observation for cholera at Hälsingborg, established in compliance with the concession of His Majesty at the expense of the town, is to be in operation the 21st of July, 1910.

In accordance with the notices issued are, until further notice, from and including the above mentioned day, stations of observation and quarantine arranged at Kånsö, near Gothenburg, and the island of Fejan in the archipelago
