ORDER of the Local Government Board: Motor Car Act, 1903: Regulations under Section 9 (1).

COUNTY OF WEST SUSSEX.

Parish of Pulborough.

To the County Council of West Sussex;— And to all others whom it may concern.

Whereas by sub-section (1) of section 9 of the Motor Car Act, 1903 (hereinafter referred to as "the Act"), it is enacted that, within any limits or place referred to in regulations made by Us, the Local Government Board, with a view to the safety of the public, on the application of the Copies of these Orders may be obtained at local authority of the area in which the limits or 4, Whitehall-place, London, S.W.

place are situate, a person shall not drive a motor car at a speed exceeding ten miles per

whereas the County Council of West Sussex having made application to Us to make a Regulation in pursuance of the said sub-section putting the above-mentioned provisions of that sub-section in force within the limits comprising part of a certain road situate within the parish of Pulborough, We directed a Local Inquiry to be held into the matter by one of Our Inspectors, and the Inquiry was held accordingly, and Report has been made to Us thereon:

Now therefore, in pursuance of the powers given to Us in that behalf, We do, by this Our

Order, make the following Regulations:—
ARTICLE I.—The provisions of sub-section (1) of section 9 of the Act with respect to the driving of a motor car at a speed not exceeding ten miles per hour shall apply and have effect within the limits comprising so much of the main road from Petworth to Steyning, within the parish of Pulborough, as extends from the railway bridge near Pulborough Station to a point opposite the eastern end of the Arun Hotel.

ARTICLE II.-These Regulations shall come into operation on the twenty-second day of August, one thousand nine hundred and ten.
