The Ministers of the Interior and of Finance: Having regard to Article 1 of the Royal Decree

of October 11, 1909;

Bring to the notice of the public that on and after August 17, 1910, the importation and transit of rags, used articles of clothing and unwashed underclothing and bedding from Kronstadt shall be prohibited.

Luggage which travellers bring with them shall be included in this prohibition so far as bedding and underclothing are concerned.

This prohibition shall not apply:

I. As regards importation and transit:

To goods which have arrived from Kronstadt but which can be shown to have come from elsewhere, and which are packed in such a manner as to render it impossible that they should have been in contact with infected

II. As regards transit:

To goods which are packed in such a manner that they cannot undergo any operation of manufacture on the way.
