TENDERS FOR LOANS ON TREASURY BILLS.

1. The Lords Commissioners of His Majesty's Treasury hereby give notice that Tenders will be received at the Chief Cashier's Office, at the Bank of England, on Thursday, the 29th instant, at one o'clock, for Treasury Bills to be issued under the Acts 40 Vic., cap. 2, 52 Vic., cap. 6, and 10 Ed. VII, and 1 Geo. V, c. 14, to the amount of £3,000,000, of which £1,500,000 will be in replacement of Bills temporarily paid off on 17th August, and £1,500,000 will be an issue under 10 Ed. VII, and 1 Geo. V, c. 14.

2. The Bills will be in amounts of £1,000, £5,000, or £10,000, and will be dated the 4th October, 1910. Bills for £1,500,000 will be payable at *six* months after date, viz.:—on the 4th April, 1911, and Bills for the remaining £1,500,000 will be payable at *four* months after date, viz.:—on the 4th February, 1911.

3. *The Tenders must specify the net amount per cent. which will be given for the amounts applied for, and the Tenders of private individuals must be made through a London Banker.*

4. The Bills will be issued and paid at the Bank of England.

5. The persons whose Tenders are accepted will be informed of the same on Friday, the 30th September, and payment in full of the amounts of the accepted Tenders must be made to the Bank of England not later than three o'clock on Tuesday, the 4th October, 1910.

6. The Lords Commissioners of His Majesty's Treasury reserve the right of rejecting any Tenders.
