ORDER of the Local Government Board: Motor Car Act, 1903: Regulations under Section 9 (1).

COUNTY OF ESSEX.

URBAN DISTRICT OF WALTHAM HOLY CROSS.

To the County Council of Essex;

And to all others whom it may concern.

Whereas by sub-section (1) of section 9 of the Motor Car Act, 1903 (hereinafter referred to as "the Act"), it is enacted that, within any limits or place referred to in regulations made by Us, the Local Government Board, with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour;

And whereas the County Council of Essex having applied to Us to make Regulations in pursuance of the said sub-section putting the above mentioned provisions of that sub-section in force within the limits comprising certain roads or parts of roads within the Urban District of Waltham Holy Cross, We caused a Local Inquiry to be made by one of Our Inspectors into the subject-matter of that application, and the report of the Inspector has been received and considered by Us:

Now therefore, in pursuance of the powers given to Us in that behalf, We do, by this Our Order, make the following Regulations:-

ARTICLE I.—The provisions of sub-section (1) of section 9 of the Act with respect to the driving of a motor car at a speed not exceeding ten miles per hour shall apply and have effect within the limits comprising the roads or parts of roads within the said Urban District which are described in the Schedule hereto.

ARTICLE II.—These Regulations shall come into operation on the twenty-sixth day of September, one thousand nine hundred and ten.

SCHEDULE.

So much of the road leading to Cheshunt as extends from its junction with the Nazeing and Sewardstone-road along Sun-street, Market-square, Church-street, and High Bridge-street to a point situate 50 yards west of the bridge known as Refinery Bridge;

So much of the Nazeing and Sewardstone-road as extends from a point situate 75 yards north of the "New Inn" to a point situate 1 furlong and 73 yards south of the said Inn; and

So much of Farm Hill-road as extends for a distance of 75 yards from its junction with the Nazeing and Sewardstone-road.

MOTOR CAR ACT, 1903.
