Information having been received that an infectious or contagious disease, dangerous to mankind, to wit Cholera, exists at Constantinople, Trebizond and the littoral between Platana and Surmene, it is hereby declared that Constantinople, Trebizond and the littoral between Platana and Surmene, the former included, are infected places, within the meaning of Article 1 of the Regulations made under the Fourth Sanitary Ordinance, 1908, published on the 28th August, 1908, as amended by Government Notices No. 199 of August 22, 1910, and No. 214 of September 2, 1910.
