head exposed. The roof and sides were in a very dangerous state, and there was a continual risk from "dribbling falls."

In spite of the imminent danger, the three men set to work with great courage and perseverance. Digging carefully with their hands and sawing off the timber as they went, they were able to make a narrow tunnel to the place where Isaac lay. After working steadily and cautiously for over nine hours, they cleared a space large enough to admit of Isaac being drawn out, and finally with a united effort they managed to drag him into a place of safety. As soon as Isaac was released from his perilous position the whole fabric collapsed.

The work of rescue was carried out with excellent coolness and skill, and, thanks to the efforts of the three rescuers, Isaac escaped' without serious injury.

hundred and one, the title and dignity of Earl of Carrick devolved upon the late Charles Henry Somerset, Earl of Carrick, deceased, as eldest son and heir of the late Charles George Butler, Captain in the 86th Regiment of Foot, whereby according to the ordinary rules of honour, Mary Emily Dew, wife of The Reverend George Platt Dew, Clerk, Rector of Shire Newton, in the county of Monmouth, the sister of the said Charles Henry Somerset, Earl of Carrick, cannot enjoy that title, rank, place and precedence which would have been due to her had her father, the said Captain Charles George Butler, survived the said Somerset Arthur, Earl of Carrick, and thereby succeeded to the title and dignity of Earl of Carrick, His Majesty has been graciously pleased to ordain and declare that the said Mary Emily Dew shall henceforth have, hold and enjoy the same title, rank, place, pre-eminence and precedence as the daughter of an Earl, to which honour she would have been entitled had her father, the said Captain Charles George Butler, succeeded to the title and dignity of Earl of Carrick.

And to command that the said Royal order and declaration be registered in His Majesty's College of Arms.
