The Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Despatch, dated October 10th, from His Majesty's Representative at The Hague, forwarding the following translation of a Decree, dated October 8th, respecting the importation of rags, &c., from any of the places situated in the Russian Governments, Provinces or Districts on the Black Sea or Sea of Azov, with the exception of the Province of Abkasia:-

The Ministers of the Interior and of Finance: Having regard to Article 1 of the Royal Decree of October 11, 1909;

Bring to the notice of the public that on and after October 10, 1910, the importation and transit of rags, used articles of clothing and unwashed underclothing and bedding from any of the places situated in one of the Russian Governments, Provinces or Districts on the Black Sea or the Sea of Azoff, with the exception, however, of the Province of Abkasia, shall be prohibited in so far as such prohibition does not already exist.

Luggage which travellers bring with them shall be included in this prohibition in so far as unwashed underclothing and bedding are concerned.

This prohibition shall not apply:

I. As regards importation and transit: To goods which have arrived from the places referred to but which can be shown to have come originally from elsewhere, and which are packed in such a manner and have been so transported as to render it impossible that they should have been in contact with infected objects;

II. As regards transit:

To goods which have been packed in such a manner that they cannot have undergone any kind of manufacture or treatment on the way.
