"And whereas we have seen fit to establish the Regulation that Officers who have entered or may enter the Accountant Branch of Your Majesty's Navy as Assistant Clerks in or after the year 1909 shall not be promoted to the rank of Paymaster until they have passed an examination to qualify them for that rank, in addition to the examination required to be passed before promotion to the rank of Assistant Paymaster:

"And whereas we consider it necessary to provide for the retirement of Assistant Pay-

masters who fail to obtain promotion:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to direct that Assistant Paymasters who have entered as Assistant Clerks in or after the year 1909, and who have been passed over for promotion to the rank of Paymaster, shall be placed on the Retired List on their attaining the age of forty years, with retired pay according to the following scale:—

"And whereas we consider it desirable to provide that the full and half-pay of Accountant Officers (other than those electing to remain on the old scale) shall in future depend upon rank, and seniority in that rank, instead of upon length

of service:

"And whereas we also consider it desirable that the remuneration of Secretaries to Flag Officers and Commodores should be based on their full pay as Accountant Officers, with the addition of an allowance varying according to the importance of the Command, and that an Accountant Officer serving as Senior Clerk to a Secretary in certain appointments should receive a daily allowance in addition to his full pay

"We beg leave humbly to recommend that Your Majesty may be graciously pleased by Your Order in Council to sanction—

"(a) the grant of full and half pay on the scale set forth in the annexed Schedule to all Accountant Officers entering Your Majesty's Navy on or after the first day of October, one thousand nine hundred and ten, and to such of the Accountant Officers previously entered as may elect to be paid on this scale as from that date;

"(b) the abolition of the scales of full and half pay for Secretaries laid down in Appendices I and IV of the Regulations for the Government of Your Majesty's Naval Service, and the substitution, as from the first day of October, one thousand nine hundred and ten, of remuneration based on the rate of full pay due as Accountant Officer with the addition of an allowance as specified in the annexed Schedule, provided:-

"(1) that the combined rate of full pay and allowance shall not (with the exceptions specified) exceed the maximum for the appointment fixed by the new scale;

"(2) that Accountant Officers other than those referred to in clause (a) hereof shall, if in future appointed as Secretaries, receive full pay due as Accountant Officer under the old scale together with the allowance specified in the annexed Schedule subject (with the exceptions specified) to the maximum remuneration fixed by the Schedule not being exceeded;

"(3) that Secretaries who would be prejudiced by the change shall continue in receipt of pay under the old scale during

their existing appointments only.
