MEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the eleventh day of October, one thousand nine hundred and ten, in the words following, viz. :-

"Whereas by section three of the Naval and Marine Pay and Pensions Act, 1865, it is enacted inter alia that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine force to a person being or having been an Officer, seaman, or marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions as are from time to time directed by Order in Council:

"And whereas we consider it desirable that the opportunity of attaining Warrant rank should be extended to the Electrician and Armourer Branches of Your Majesty's Navy, for which there is at present no higher grade than the rating of Chief Petty Officer, and further that Commissioned Warrant rank should be open to the Electrician Branch:

"And whereas we further consider it desirable that the service qualification for the advance-ment of Electricians to the rating of Chief Electrician, Second Class, shall be the same as is required of an Engine Room Artificer for advancement to Chief Engine Room Artificer, Second Class:

"We beg leave humbly to recommend that Your Majesty may be graciously pleased by
