But the Principal and Fellows may for marriage or other special reasons give leave to one of these four to reside in a house authorised by the Principal and Fellows for the purpose and contiguous to the College buildings, so that nevertheless the number of three unmarried Official Fellows resident within the College walls shall always be maintained.

STATUTE III.

Part V. Supernumerary Fellowships.

Any Official Fellow whose term of service shall have reached 25 years may, in lieu of being retired on a pension as hereinafter provided under Statute XII, by a special vote of the Principal and Fellows and with his own consent, be elected to a Fellowship with a stipend of 300*l.*, clear of income-tax, payable out of the Pension Fund, but without any other (save the dinner) allowance.
