STATUTE VI.

*Substitute for clause 1:*

1. A sum of not less than 1000*l.* shall be provided annually from the corporate revenues of the College for the maintenance of not less than twelve College Scholarships of the yearly value of 80*l.*, inclusive of all privileges and allowances, and for the augmentation to the yearly value of 80*l.* of Scholarships on the Somerset foundation thrown open for that turn to public competition.

STATUTE VII.

1. Of the Scholarships founded by Sarah, Duchess of Somerset, three shall be called Somerset Iver Scholarships, and the remainder Somerset Thornhill Scholarships.

The three Somerset Iver Scholarships shall be limited in the first instance to persons educated at the Grammar School of Manchester, and shall be of the annual value of 80*l.*

lines 5—9. *For such examination . . . the University. read: such examination, if any, as the Principal and Fellows shall determine) it shall be lawful for the Principal and Fellows to give preference to any fit candidate holding an exhibition upon the Charlbury Exhibition Foundation as established by the Scheme of the Board of Education approved by the King in Council on 10 August 1909.*

11. Every pension shall be paid direct to the pensioner and shall be available for his alimony only, provided that under special order payment may be made to trustees on behalf of the pensioner. No part of any pension shall be assignable or transferable or in any way negotiable without the consent of the Principal and Fellows under pain of forfeit. Such consent shall only be given under the seal of the College authorized by a resolution taken under the conditions of voting prescribed in clause 9 of Part II of Statute III.
