BYE-LAW UNDER THE LOCOMOTIVES ACT, 1898.

COUNTY PALATINE OF LANCASTER.

Notice is hereby given, that at a meeting of the County Council of the County Palatine of Lancaster, held in the County Hall, in Preston, on Thursday, the 2nd day of February instant, the said County Council, in pursuance of the provisions of section 6 (1) of the Locomotives Act, 1898, did make the following bye-law with respect to locomotives in the administrative county of Lancaster, viz. :—

From and after the date of the confirmation of this bye-law the bye-law numbered 6 (six) in the bye-laws under the Locomotives Act 1898, which were made by the County Council of the County Palatine of Lancaster, on the first day of November, 1900, and were confirmed by the Local Government Board on the twenty-ninth day of January, 1901, and so much of the schedule to such bye-laws as remains unrepealed by the Bye-laws under the Locomotives Act, 1898, which were made by the said County Council on the fourth day of May, 1905, and third day of May, 1906, and were confirmed by the Local Government Board on the fifth day of July, 1905,

and the twelfth day of July, 1906, respectively, shall be repealed.

And notice is hereby further given, that the County Council intend to apply to the Local Government Board for confirmation of the foregoing bye-law at the expiration of one month from the date when the same has been duly advertised in one or more local newspapers circulated within the said county, and in the London Gazette, pursuant to the provisions of section 184 of the Public Health Act, 1875.
