I hereby give notice, pursuant to the 9th section of the Act 5 and 6 Victoria, cap. 110, intituled "An Act for better preserving the Navigation of the River Mersey," that I have received notice from the Lord Mayor, Aldermen and Citizens of the City of Liverpool, given pursuant to the provisions of the above mentioned Act, of their intention to construct a river wall or embankment along the foreshore of the River Mersey, at the western end of Riversdale Road, Garston, in the City of Liverpool, in accordance with plans and sections deposited at this office, a copy of which notice is subjoined.

In pursuance of an Act for better preserving the navigation of the River Mersey (5 and 6 Vic., cap. 110), we, the Lord Mayor, Aldermen and Citizens of the City of Liverpool hereby give you notice that we propose to construct at the western end of Riversdale Road, Garston, in the City of Liverpool, in accordance with plans and sections deposited at the office of the Mersey Conservancy, a river wall or embankment running for a distance of 321 feet or thereabouts along the foreshore of the River Mersey in a south-eastwardly direction from Riversdale Road aforesaid. The said wall will be in line with the existing walls and will be substantially built of concrete on the rock foundation.

The ground behind the wall will be filled in so as to bring it up to the level of the top of the wall.

It is proposed to commence the said works in the month of June next.
