His Majesty's Minister at Christiania, transmitting the following translation of a Circular, dated 4th April, issued by the Norwegian Government, relating to places infected with cholera and plague:—

All places mentioned as infected with cholera in the Circular dated the 22nd February, 1911, namely, the Island of Madeira, the Russian Governments of Podolia, Kieff, and Ekaterinoslav, the Province of Lecce, in Italy, and the town of Smyrna, in Asia Minor, are now regarded as free from cholera.

The towns of Odessa, in Russia, and Port of Spain, on the Island of Trinidad, in the West Indies, shall be regarded, until further notice, as infected with oriental plague.

#### GOVERNMENT NOTICE.

With reference to Government Notices Nos. 237 of 1909 and 177, 234, 248 and 307 of 1910, it is hereby notified that Yalta, Nicolaiev, Constantinople, Trebizond and the littoral between Platana and Surmene, Zoungouldak and Erenkeui, Kerassonde and Ordou on the Black Sea are no longer regarded as places infected with cholera, within the meaning of article 1 of the Regulations made under the Fourth Sanitary Ordinance, 1908, and published on the 28th August, 1908, as amended by Government Notices Nos. 199, 214, 243, 290 and 324 of 1910; and with reference to Government Notice No. 75 of 1910, it is hereby notified that Bengazi is no longer regarded as a place infected with small-pox, within the meaning of article 1 of the Regulations above quoted.
