MOTOR CAR ACT, 1903.

COUNTY OF BUCKINGHAM.

Whereas by sub-section 1 of section 9 of the Motor Car Act, 1903, it is enacted that within any limits or place referred to in regulations made by the Local Government Board with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour:

And whereas the County Council of Buckingham have made application to the Local Government Board for a regulation to be made in pursuance of the said sub-section putting the above-mentioned provisions of that sub-section in force within the limits comprising so much of the main road through the town of Stony Stratford as extends from a point opposite the south-eastern corner of St. Mary's Church to a point opposite the north western corner of the Gas Works,

And whereas notice of the said application and of the time and manner in which objections should be made to any such regulation appeared in the London Gazette of the 11th day of April, 1911, and in the Buckingham Advertiser, and the Bucks Standard, of the 15th day of April, 1911.

And whereas certain objections to the making of any regulation in pursuance of the said provisions have been received by the Local Government Board, and it is expedient that further inquiry should be made in the matter of the said application:

ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 6TH JUNE 1911.)

(SWINE-FEVER INFECTED AREA.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1910, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Declaration of Swine-Fever Infected Area.

1. The Area described in the Schedule to this Order is hereby declared to be a Swine-Fever Infected Area for the purposes of the Swine-Fever (Regulation of Movement) Order of 1908.

Commencement.

2. This Order shall come into operation on the tenth day of June, nineteen hundred and eleven.
