And whereas the said Bishop as patron, and the Reverend Greville Turner Brunwin-Hales, the Reverend Walter Edmund Spencer, the Reverend Wilfred Henry Courteen, the Reverend Charles Cuthbert Naters, and the Reverend Arthur Chamberlain Green, as incumbents of the said benefices of St. Mary the Virgin, St. Botolph, St. Paul, St. James and St. Martin respectively, Pelham Rawstorn Papillon as patron and the Reverend James Mellor Evans as incumbent of the said benefice of Lexden, the Master and Fellows of Balliol College, Oxford, as patrons, and the Reverend E. R. Monck-Mason as incumbent of the said benefice of Holy Trinity; the said Master and Fellows of Balliol College, Oxford, and the Right Honourable James Round as patrons, and the Reverend Thomas Walter Gilbert as incumbent of St. Nicholas with St. Runwald; the Reverend Nicolas Parker Gepp as patron and the Reverend J. B. Marsh as incumbent of St. Giles; the Right Honourable the Lord High Chancellor (on behalf of His Majesty) as patron and the Reverend Robert Bashford and the Reverend Clement A. Worsfold as incumbents of the said benefices of St. Mary Magdalen and Greenstead respectively; the Reverend Robert Baker Girdleston, the Reverend Ernest Augustus Eardley-Wilmot, the Reverend Arthur Evelyn Barnes-Lawrence, the Reverend Alexander Stuart and the Reverend James Denton Thompson as patrons, and the Reverend Charles Triffit Ward as incumbent of St. Peter have consented to the said Scheme:

And whereas the said Scheme hath been transmitted by the said Bishop to the said Archbishop for his consideration.

And whereas the said Archbishop, being satisfied with the said Scheme, hath certified the same, and the Consents to His Majesty in Council in the words and figures following:—

" We, the undersigned Randall Thomas, Archbishop of the Province of Canterbury, do hereby report to Your Majesty in Council

" That the Right Reverend Edgar Bishop of St. Albans, has represented unto Us (amongst other things)

" That the borough of Colchester, in the county of Essex and his diocese of St. Albans, contains within its limits several ecclesiastical parishes the ancient boundaries whereof are very irregular, and in certain cases there are detached portions of such parishes lying at a distance from their parish church and wholly surrounded by other parishes, so that the cure of souls within the said borough cannot be effectually administered without extensive alterations of the boundaries of such parishes.

" That it appears to him, the said Lord Bishop, that under the provisions of the Pluralities Act, 1838, the several alterations of boundaries may be effected and certain districts which are contiguous to or are sur-

rounded by other parishes may be advantageously separated from the several parishes to which they now belong and be annexed to such other parishes for ecclesiastical purposes only.

" That pursuant to the directions contained in the 26th section of the first-mentioned Act of Parliament the said Lord Bishop has drawn up a Scheme in writing annexed to his Representation describing the several districts so as aforesaid proposed to be annexed to the respective parishes of Lexden, St. Mary the Virgin, Colchester, Holy Trinity, Colchester, St. Giles, Colchester, St. Botolph, Colchester, St. Mary Magdalen, Colchester, St. Peter, Colchester, St. Paul, Colchester, St. James, Colchester, and Greenstead, all situate within the said diocese of St. Albans, and the mode in which it appears to him that the proposed alterations may best be effected, and how the changes consequent on such alterations in respect to ecclesiastical jurisdiction, glebe lands, tithes, rentcharges, and other ecclesiastical dues, rates and payments, and in respect to patronage and rights to pews may be made with justice to all parties interested. The said several districts so as aforesaid proposed to be annexed to the several parishes hereinbefore named are separately and fully described, with the several boundaries thereof, in the first part or section of the Scheme of the said Lord Bishop, and are distinguished by numbers and colours in the said section and also in the map or plan numbered 1 which is referred to in and which accompanies the said Scheme of the said Lord Bishop. The consequent altered boundaries of the several parishes affected are delineated in a map or plan numbered 2, which also accompanies the said Scheme, and are set out and described in several Schedules to the said Scheme as follows, viz.: The new and altered boundaries of (a) the parish of Lexden in the 1st Schedule to the said Scheme, (b) the parish of St. Mary the Virgin, Colchester in the 2nd Schedule thereto, (c) the main portion of the parish of Holy Trinity, Colchester, in Part I. of the 3rd Schedule thereto, (d) the detached portion of the said parish of Holy Trinity, Colchester in Part II. of the said 3rd Schedule thereto, (e) the parish of St. Giles, Colchester, in the 4th Schedule thereto, (f) the parish of Saint Botolph, Colchester, in the 5th Schedule thereto, (g) the parish of St. Mary Magdalen, Colchester, in the 6th Schedule thereto, (h) the parish of St. Peter, Colchester, in the 7th Schedule thereto, (i) the parish of St. Paul, Colchester, in the 8th Schedule thereto, (k) the united parishes of St. Nicholas and St. Runwald, Colchester, in the 9th Schedule thereto, (l) the parish of St. James, Colchester, in the 10th Schedule thereto (m) the parish of St. Martin, Colchester, in the 11th Schedule thereto, and (n) the parish of Greenstead in the 12th Schedule thereto.
