" The patrons or persons entitled to present to the aforesaid benefices if vacant, and the incumbents of the same several benefices affected by the proposed alterations in the said Scheme are named in the 1st Schedule to the 'Consent' which is annexed to such Scheme of the said Lord Bishop, and the whole of such persons being all the persons whose consents are by the Pluralities Act, 1838, severally required to the aforesaid alterations have duly signified their consents in writing to the said Scheme.

"And the said Lord Bishop has transmitted to Us for Our consideration his said Representation and Scheme and the plans and schedules therein referred to, together with the said Consents in writing of the said patrons and incumbents, and the same are herewith sent.

"And We, the said Archbishop, being on full consideration and inquiry satisfied with the said Scheme, do hereby, pursuant to the said Pluralities Act, 1838, certify the same and such Consents as aforesaid to Your Majesty in Council to the intent that Your Majesty in Council may, in case Your Majesty in Council shall think fit so to do, make and issue an Order for carrying the said Scheme into effect.
