## ORDER OF THE REGISTRAR-GENERAL IN ENGLAND.

### (Dated August 9th, 1911.)

Whereas by the 21st section of the Births and Deaths Registration Act, 1874, it is enacted that the Registrar-General, with the sanction of the Local Government Board, may from time to time alter Registration Sub-Districts:—

1. And whereas it is expedient that the Sub-Districts of Gloucester Registration District should be re-arranged in the following manner, viz.: (1) that Alington Ward of Gloucester County Borough should be transferred from Gloucester Southern Sub-District to Gloucester Northern Sub-District; and

(2) that the rural Civil Parishes of Elmore, Hempstead, Matson, Prinknash Park, Quedgeley, Upton St. Leonards, and Whaddon should be transferred from Gloucester Southern Sub-District to Barnwood Sub-District;

2. Now, therefore, I, Bernard Mallet, C.B., Registrar-General of Births, Deaths, and Marriages in England, in exercise of the powers given me by the above mentioned Act, and with the sanction of the Local Government Board, do hereby order and declare that the foregoing alteration shall take effect accordingly.

3. This Order shall come into operation on first day of September, nineteen hundred and eleven.

By the Second Schedule to the Order the following sections of the Norwich Corporation Act, 1889, are repealed on and after the date on which this Order comes into operation:— Section 21; and section 46, so far as the section relates to any subject-matter of section 47 of the Act of 1907.
