This Declaration, it is stated, specifies cannon, firearms, and sidearms of all descriptions, munitions of war, military tools of all kinds, and generally everything which without manipulation can be put to immediate use in connection with maritime or land warfare.

As soon as the actual text of the Declaration is received by His Majesty's Government it will be published in the London Gazette.

(iv) of Clause 5, section II, C. Healthy ships, Part I of the Regulations for the prevention of contagious, infectious and epidemic diseases made under the said ordinance, re-published by Government Notice No. 207 of the 13th July, 1911, and amended by Government Notices No. 224 of the 29th July, 1911, and No. 252 of the 22nd August, 1911, viz.:

"The following words are added after the word 'place' in the fourth line, viz.: 'or from the date of arrival according as the Quarantine Medical Officer may consider advisable.""
