To lay cables in the bed of the River Weaver between Weston Marsh Lock and Frodsham Bridge, in the line shown on the site plan, for the purpose of conveying Electrical Energy from the Weston Point Power Station of the company to the districts of Frodsham and Helsby.

Three cables are proposed in all—two power cables, and one telephone cable. The cables will be paper insulated lead sheathed and double wire armoured.
