The Civil Service Commissioners hereby give notice, that Open Competitive Examinations of candidates for entry as Apprentices in His Majesty's Dockyards and as Boy Artificers in

THE MOTOR CAR ACT, 1903.

COUNTY OF LONDON.

Whereas the London County Council have made application to the Local Government Board for the issue of regulations—

(a) Under section 6 of the Locomotives on Highways Act, 1896, and section 8 of the Motor Car Act, 1903, for restricting to five miles per hour the speed at which any motor car may be driven upon the following highways or parts of highways within the metropolitan borough of Hammersmith; that is to say:—

The Broadway;

So much of Queen Street as extends from the Broadway to a point 50 yards south of the southern side of Bridge Road;

So much of Bridge Road as extends for a distance of 50 yards from its junction with the Broadway;

So much of King Street as extends from its junction with the Broadway to the eastern side of the Grove;

So much of Beadon Road as extends from the Broadway to the eastern side of the Grove;

So much of Brook Green Road as extends from the Broadway to a point 16 yards north of the northern side of the Town Hall; and

So much of Hammersmith Road as extends from the Broadway to a point 14 yards east of the eastern side of Union Court; and

(b) Under sub-section 1 of section 9 of the Motor Car Act, 1903, for restricting to ten miles per hour the speed at which any motor car may be driven within the limits comprising so much of Hammersmith Road within the metropolitan borough of Hammersmith as extends from a point 14 yards east of the eastern side of Union Court to the western side of Brook Green.

And whereas notice of the said application and of the time and manner in which objections should be made to any such regulation appeared in the London Gazette of the 27th day of June, 1911, and in the "West London Observer" of the 30th day of June, 1911;

And whereas certain objections to the making of any regulation in pursuance of the said provisions have been received by the Local Government Board, and it is expedient that further inquiry should be made in the matter of the said application:
