(3) No person shall be eligible to a Fellowship of this class who has not passed all the examinations required by University for the degree of B.A. person shall be ineligible because he is in possession of property or income which may disqualify him from receiving all or any part of the emoluments of a Fellowship

(5) Whenever there is no candidate for a vacant Fellowship of this class, whom on the results of the examination the electors judge to be of sufficient merit for election, the Warden and Fellows shall not be bound to proceed to an election.

(8) Seven other Fellowships shall be awarded after examination or without examination as the Warden and Fellows may from time to time determine, but subject to the following conditions:-

Any person may be elected who, being in the judgment of the Warden and Fellows qualified by character and attainments to be a Fellow of the College, undertakes to prosecute in the College or the University, or under the direction of the College or University elsewhere, some definite literary or scientific work, which shall be specified in the Resolution by which he is elected. Before proceeding to an election the Warden and Fellows shall communicate their intention to the Hebdomadal Council, and shall consider any representation which the Council may make upon the subject.

An election to not more than one such Fellowship may be made, but shall not be required to be made, in each year. Fellow elected under this clause may be re-elected in like manner and under like

conditions from time to time.

(21) No Fellowship in the College shall be tenable with a Headship, or a Fellow-ship other than an Honorary Fellowship, in any College within the University.

That in clause 12 (formerly 11) of Statute III the word "three" be removed and the word "five" be substituted in its place.

That in clause 14 (formerly 13) of Statute III the signs of parenthesis in the fourth line of such clause and the letter A standing before the latter of such signs be removed.

That in clause 17 (formerly 16) of Statute III the numbers 7 and 10 in the second line of such clause be removed and number 8 be substituted for number 7, and the number 12 be added immediately after number 11.

That in clause 19 (formerly 18) of Statute III the words "or Readership" be added immediately after the word "Professorship" in such clause.

That in clause 20 (formerly 19) of Statute III the word and number "clause 10" be removed and the words and numbers "clauses 8 and 12" be substituted in their

In Statute IV.—That the whole of Statute IV be repealed, and a new Statute in the words and figures following be substituted in its place, namely:-

IV.—University officers connected with the College.

1. There shall be payable out of the Revenues of the College appropriated to the purposes of these Statutes the annual sums following:-

To the Chichele Professor of International Law, £700.

To the Chichele Professor of Modern

History, £700.

To the Vinerian Professor of English Law such a sum as, together with what he shall receive from the Vincrian Fund, shall amount to £700.

To the Regius Professor of Civil Law such a sum as, together with what he shall receive in respect of his Professorship from other sources, shall amount to £700.

To the Chichele Professor of Military

History, £300.

To the Drummond Professor of Political Economy such a sum as, together with what he shall receive from Mr. Drummond's Foundation, shall amount to £300.

To the Reader in Political Theory and Institutions such a sum as, together with what he shall receive from the Oxford University Endowment Fund, shall amount to £300.

Each of the above named Professors and the Reader in Political Theory and Institutions shall also receive out of the Revenues of the College appropriated as aforesaid the yearly sum of £200 as the emolument of a Fellowship held by him in the College.

2. The foregoing provisions shall only take effect on the condition that the election or appointment of each of the above named Professors (except the Regius Professor of Civil Law) and of the Reader shall be vested in an Electoral Board, constituted by a Decree or Statute made by or for the University, of which one member at least shall be a person to be nominated by the Warden and Fellows

The provision as to the Reader in Political Theory and Institutions shall have effect until July 1st, 1920.

3. Subject to the provision of Statute XII, clause 3, no person elected or appointed under the preceding clauses shall be entitled to receive any payment from the revenues of the College, unless he becomes a Fellow of the College, nor if and so long as he holds a Headship or a other than an Honorary Fellowship, other than an Ho Fellowship, in any other College.

4. A Professor or Reader who holds a Fellowship under clause 1 of this Statute may be deprived of it for the same causes and in the same manner as other Fellows, and the bye-laws may be enforced against him. In case of his being so deprived, the yearly sum of £200, constituting the emoluments of his Fellowship, shall sink into the fund appropriated to the purposes of these Statutes, but the sum further payable to him under the foregoing provisions shall continue to be payable so long as he holds his Professorship or Readership.

If he cease to hold his Professorship or Readership he shall thereupon vacate his

Fellowship.

5. There shall be payable out of the Revenues of the College appropriated as aforesaid : -

To the Reader in Indian Law, £400. To each of the All Souls Readers in Law, £400.
