

## CITY OF YORK.

NOTICE is hereby given, that pursuant to the provisions of the Borough Funds Acts, 1872 and 1903, a special meeting of the Lord Mayor, Aldermen and Citizens of the City of York, acting as the Council and also as the Urban District Council of the said City, will be held in the Council Chamber, Guildhall, of and in the said City, on Monday, the 4th day of March, 1912, at Twenty-five minutes past Six o'clock in the evening, for the purpose of taking into consideration the following Bill intended to be introduced into Parliament in the ensuing Session, and which Bill affects the interests of the inhabitants of the said City, viz.:—

"A Bill to consolidate the York United Gas Light Company's Special Acts; to extend their limits of supply; to authorize the Company to construct additional works and to raise additional capital; to change the name of the Company; and for other purposes."

At which meeting a resolution will be submitted to the Council to the effect that in their judgment it is expedient for them, in the interests of the inhabitants of the said City, to oppose the said Bill; and that the costs, charges and expenses of or in relation to the opposition of the said Bill, and to be incurred by the said Council, be charged on the Borough Fund and General District Fund in such proportions as the Council may then and there determine.
