Marques, stating that, in consequence of the outbreak of plague at Durban, all vessels clearing from that port are subjected on arrival at Lourenço Marques to six hours' sanitary detention for fumigation purposes before being allowed to make fast to the wharves, and that passengers disembarking are ordered to report themselves daily for twelve days to the local sanitary authority.
