ORDER OF THE REGISTRAR GENERAL IN ENGLAND.

(Dated 23rd March, 1912.)

Whereas by the 21st section of the Births and Deaths Registration Act, 1874, it is enacted that the Registrar General, with the sanction of the Local Government Board, may from time to time alter registration sub-districts:—

- 1. And whereas it is expedient, in the interest of public convenience, that the civil parishes of Broncastellan and Trefeirig should be transferred from Aberystwith and Rheidol sub-districts respectively of Aberystwith registration district to Geneurglynn sub-district of the same registration district;
- 2. Now, therefore, I, Bernard Mallet, C.B., Registrar General of Births, Deaths, and Marriages in England, in exercise of the powers given me by the above-mentioned Act, and with the sanction of the Local Government Board, do hereby order and declare that the
