The following Statute made by the Governing Body of Clare College, Cambridge, on the 25th day of May, 1912, and sealed on the 16th day of July, 1912, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1877":—

A STATUTE to alter the Statutes framed by the Commissioners appointed under the "Universities of Oxford and Cambridge Act 1877" in relation to Clare College in the University of Cambridge such amending Statute being duly made at a general Meeting of the Governing Body of the said College specially summoned for the purpose and held on the 25th day of May 1912 and passed at the said General Meeting by the votes of ten of the twelve persons present and voting and now submitted for the approval of His Majesty the King in Council.

We the Master and Fellows of the said College in exercise of the powers given to us by the 54th section of the said Act do hereby alter the Statutes framed by the said Commissioners in manner following, that is to say:—

By omitting in Statute 18 the first paragraph, namely, the words "The Master shall occupy that portion of the western side of the College which lies to the north of the Archway, and also the room therewith connected which is above the Library" and by substituting for these words the following words, namely:—

"The College shall provide a suitable residence for the Master."
