The Wild Birds Protection (County Borough of Tynemouth) Order, 1912.

### Dated 22nd August, 1912.

In pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1908, and upon application by the Council of the County Borough of Tynemouth, I hereby make the following Order:—

#### Title.

I. This Order may be cited as "The Wild Birds Protection (County Borough of Tynemouth) Order, 1912."

#### BIRDS.

# Certain Birds Protected during the Whole of the Year.

II. During that period of the year to which the protection afforded by the Wild Birds Protection Act, 1880, does not apply, the killing or taking of the following species of Wild Birds is prohibited throughout the County Borough of Tynemouth:—

Hedge Accentor (Hedge Sparrow, Dunnock), Blackbird, Bullfinch, Diver, Dotterel, Dunlin, Eider Duck, Goldfinch, Sparrow Hawk, Jackdaw, Kingfisher, Larks, Brown Linnet, Green Linnet, Sand Martin, Nightjar (Fern Owl, Goat Sucker, Night Hawk), Owls, Oyster Catcher, Redwing, Robin (or Redbreast), Starling, Thrushes, Blue Tit, Wrens.
