#### LIGHT RAILWAYS ACT, 1896.

##### HARRINGTON AND LOWCA LIGHT RAILWAY ORDER.

The Light Railway Commissioners have submitted to the Board of Trade for confirmation, under the above-mentioned Act, an Order made by them authorising the acquisition, reconstruction, and working for passenger traffic as a Light Railway under the Light Railways Act, 1896, of an existing Mineral Railway from the Harrington Collieries at Lowca to Harrington, in the county of Cumberland.

Any objections to the confirmation of the Order should be addressed to the Assistant Secretary (Railway Department), Board of Trade, Whitehall Gardens, London, S.W., and must be lodged with the Board on or before the 7th November, 1912.
