protection of Viscount Tredegar) of that Act and for that purpose to repeal or amend any provisions of that section or Act inconsistent with such revival or extension.

To provide that the supply of water to be given by the Board and to be taken by the Llantrisant and Llantwit Fardre Rural District Council under sub-section (4) of Section 59 of the Act of 1910 shall be so given and taken from and after the time when the Board receive from the Corporation the supply of water to be given by the Corporation under the before mentioned Agreement dated the 3rd day of July, 1912, in lieu of being so given and taken from and after the time when the Board are in a position to supply water from the Llia reservoir and works which the Board are by the Act of 1910 authorized to construct and to alter, adapt, amend or repeal the provisions or some of the provisions of the said section so far as may be necessary for giving effect to the purpose aforesaid.

To increase or alter all or any of the rates, rents and charges now levied or leviable by the Board and to enable the Board to levy and recover as from the date of the passing of the intended Act or as from such other time or times as may be prescribed by the intended Act the respective rates set out in the third column of the seventh Schedule to the Act of 1910 free from all or any of the restrictions or conditions contained in that Act or such other rates, rents and charges as the intended Act may prescribe whether for domestic purposes or for purposes other than domestic and to alter, amend or repeal the provisions of that Act so far as may be necessary to give effect to the purposes aforesaid.

To provide that the Board shall not be bound to supply water by measure for other than domestic purposes and to alter or repeal so much of Section 67 of the Act of 1910 as imposes any such obligation upon the Board.

To empower the Board to require the use by consumers of meters supplied by the Board and to prescribe the position in which any such meter shall be fixed.

To authorize the application by the Board towards the construction of the works to be authorized by the intended Act of any moneys which the Board are authorized to raise or have raised for the purposes of their water undertaking.

To authorize the Board to borrow money for the purposes of the intended Act and for paying the costs, charges and expenses of and incident to the opposition by the Board to the Merthyr Corporation Water Bill, 1911, and the Rhymney Valley Water Board Bill, 1911, and of and incident to the said Agreement dated the 3rd day of July, 1912, and to charge the moneys so borrowed on the water undertaking, works, lands and property, rents and revenue of the Board and other moneys and rates which they are or may be authorized to raise or levy or on one or more of such securities and to empower the Board to grant and issue mortgages, debentures and debenture stock in respect thereof and to create and issue annuities chargeable upon the water undertaking, rates and property aforesaid.

To authorize the Board to create and issue stock in the manner provided by Part V. of the Public Health Acts Amendment Act, 1890, with such amendments and modifications as the intended Act may prescribe. To confer upon the Board all powers, rights, authorities and privileges which are or may become necessary for carrying the powers of the intended Act into execution and to vary and extinguish all rights and privileges inconsistent with or which might in any manner impede or interfere with the carrying into complete effect any of the objects and purposes of the intended Act and to confer other rights and privileges and to enact all such provisions as may be incidental to consequential on or necessary for giving full effect to any of the objects of the intended Act.

To alter, amend and repeal so far as may be necessary for the purposes of the intended Act the provisions or some of the provisions of the Act of 1910 and any other Act relating directly or indirectly to the Board and the intended Act will or may incorporate with itself with or without modification such of the provisions as may be deemed expedient of the Act of 1910 and the following Acts, viz.:--The Lands Clauses Acts; the Waterworks Clauses Acts, 1847 and 1863; the Railways Clauses Consolidation Act, 1845; the Public Health Acts; the Local Loans Act, 1875; the Arbitration Act, 1889; and all other Acts amending the said Acts respectively.

Duplicate plans and sections of the intended works showing the lands and property to be taken or used compulsorily under the powers of the intended Act, together with a book of reference to such plans and a copy of this Notice as published in the London Gazette, will be deposited for public inspection on or before the 30th day of November instant with the Clerk of the Peace for the county of Glamorgan at the County Hall, Cardiff, and on or before the same day a copy of so much of the said plans, sections and book of reference as relates to each of the areas hereinafter mentioned with a copy of this Notice published as aforesaid will be deposited for public inspection as follows (that is to say):—

In respect of the parish of Merthyr Tydfil. in the county borough of Merthyr Tydfil, with the Town Clerk of that borough at his office at Merthyr Tydfil; in respect of the parish of Llanwonno, in the urban district of Mountain Ash, with the Clerk of the urban district council of Mountain Ash at the Town Hall, Mountain Ash; in respect of the parish of Pontypridd, in the urban district of Pontypridd, with the Clerk of the Pontypridd Urban District Council at his office at Pontypridd; in respect of the parish of Rhondda, in the Rhondda Urban District, with the Clerk of the Rhondda Urban District Council at his office at Pentre; and in respect of the parish of Llantrisant with the Clerk of the Llantrisant Parish Council at the Parish Offices, Llantrisant; and with the Clerk of the Llantrisant and Llantwit Fardre Rural District Council at his office at Court House-street, Pontypridd.
