#### TRADE BOARDS ACT, 1909.

At the Council Chamber, *Whitehall*, this twelfth day of *March*, 1913.

PRESENT,

The Right Honourable Sydney C. Buxton,

In pursuance of the powers conferred upon them by the Trade Boards Act, 1909, the Board of Trade are pleased to establish a Trade Board for those branches of the Readymade and Wholesale Bespoke Tailoring Trade in Ireland which are engaged in making garments to be worn by male persons, and for those branches of the Bespoke Tailoring Trade in Ireland which are engaged in making garments to be worn by male persons and in which

at least three persons or two female persons (in both cases exclusive of cutters) are engaged in making one garment, constituted in accordance with the Regulations for the above mentioned branches of trade dated 3rd July, 1912

The Trade Board shall consist of:—

(1) three appointed members, namely:—

Mr. E. Aves,  
Mr. Dominic J. Daly, and  
The Hon. Ethel Macnaghten,

who are hereby directed to act on the Trade Board;

(2) six members representing employers who are occupiers of factories within the meaning of the Factory and Workshop Acts, and are not habitually engaged in sub-contracting, such members to be elected in accordance with the Regulations above mentioned;

(3) four members representing employers (other than those employers who are occupiers of factories within the meaning of the Factory and Workshop Acts and are not habitually engaged in sub-contracting), who, being unopposed candidates, are hereby declared to have been duly elected in accordance with the Regulations, namely:—
