"All that detached portion of the township of Creighton, in the said Parish of Stramshall, containing an area of 26.789 acres or thereabouts, bounded on the west by the district comprised in the First Part of this Schedule, and on all other sides by the said Parish of Croxden, and marked 'Burton Div. (Det.) Uttoxeter Rural (Det. No. 1)' on the 25-inch Ordnance Map, and more particularly delineated and described on the plan hereunto annexed, and thereon coloured Yellow."

"That there is also in the same County and Diocese the Benefice (being a New Vicarage or Perpetual Curacy) of Stramshall
