"That pursuant to the directions contained in the said Act, the said Lord Bishop has drawn up a Scheme in writing describing the mode in which it appears to him that the proposed alterations may best be effected, and how the changes consequent on such alterations in respect to Ecclesiastical jurisdiction, glebe lands, tithes, tithe rent charges, and other Ecclesiastical dues, rates, and payments, and in respect to patronage and rights to pews may be made with justice to all parties interested, which Scheme, together with the Consents thereto in writing of the Reverend Edward Philips, patron of the said Benefice of Checkley, the Reverend George William Philips, the Incumbent of the said Benefice, Right Honourable George Loveden the William Henry, Earl of Macclesfield, patron of the said Benefice of Croxden, the Reverend Edward Philips, the Incumbent of the said Benefice, the Reverend William Charles Granville Sharp, patron of the said Benefice of Stramshall, and \mathbf{the} Reverend Charles Frederick Lowry Barnwell, the Incumbent of the said Benefice, has been transmitted to us

by the said Lord Bishop for our consideration. "And we, the said Archbishop, being on full consideration and enquiry satisfied with the said Scheme, do hereby, pursuant to the said Pluralities Act, 1838, Certify the same and such Consents as aforesaid to Your Majesty in Council to the intent that Your Majesty in Council may in case Your Majesty in Council shall think fit so to do, make and issue an Order for carrying the said Scheme into effect.

W HEREAS by the Burial Act, 1855, it is, amongst other things, provided that it shall be lawful for His Majesty, by and with the advice of His Privy Council, from time to time to postpone the time appointed by any Order in Council for the discontinuance of burials, or otherwise to vary any Order in Council made under any of the Acts recited in the said Act, or under the said Act (whether the time thereby appointed for the discontinuance of burials thereunder, or other operation of such Order, shall or shall not have arrived), as to His Majesty, with such advice as aforesaid, may seem fit:

And whereas an Order in Council was made on the 7th day of April, 1854, directing the discontinuance of burials in, amongst other places, certain parts of the burial-ground of the Cathedral of Saint Augustine, Bristol, and that only one body be buried in each grave:

And whereas it seems fit to His Majesty, by

and with the advice of His Privy Council, that so much of the said Order in Council as relates to the said burial-ground of the said Cathedral should be varied:

Now, therefore, His Majesty, by and with the advice aforesaid, is pleased to order, and it is hereby ordered, that so much of the said Order in Council of the 7th day of April, 1854, as relates to the burial-ground of the Cathedral of Saint Augustine, Bristol, be varied by the substitution for the words "only one body to be buried in each grave " of the words " only one body to be buried in each grave other than an earthen grave, and not more than two bodies in each carthen grave."
