

the County Borough of Barrow-in-Furness, I hereby make the following Order:—

*Title.*

I. This Order may be cited as "The Wild Birds Protection (County Borough of Barrow-in-Furness) Order, 1913."

**BIRDS.**

*Close Time Extended.*

II. The time during which the killing or taking of Wild Birds is prohibited by the Wild Birds Protection Act, 1880, shall be extended, so far as concerns the County Borough of Barrow-in-Furness, so as to be between the 31st day of January and the 1st day of September in any year, except with respect to the following birds:—Mallard, Wild Duck, Snipe, Teal (other than Garganey), Widgeon, and Woodcock.

*Additions to the Schedule of the Act of 1880.*

III. The Wild Birds Protection Act, 1880, shall apply within the County Borough of Barrow-in-Furness to the following species of Wild Birds in the same manner as if those species were included in the Schedule to the Act:—

Hedge Accentor (Hedge Sparrow), Blackbird, Black-headed Bunting, Common Bunting, Yellow Bunting (Yellow Hammer), Buzzard, Creeper, Dipper, Stock Dove, Pied Flycatcher, Spotted Flycatcher, Hawfinch, Heron, Hobby, Kestrel, Linnets, House Martin, Sand Martin, Merlin, Moorhen, Nut-hatch, Ring Ouzel, Pipits, Lesser Redpoll, Redstart, Robin, Stonechat, Swallow, Swift, Thrush, Tits, Pied Wagtail, Grey Wagtail, Yellow Wagtail, Blackcap Warbler, Garden Warbler, Reed Warbler, Sedge Warbler, Willow Warbler, Wood Warbler, Wheatear, Whinchat, Whitethroat, Lesser Whitethroat, Wren, Golden-crested Wren.

*Certain Birds Protected during the whole of the Year.*

IV. During that period of the year to which the protection afforded by the Wild Birds Protection Act, 1880, as extended by Clause II of this Order, does not apply, the killing or taking of any of the following species of Wild Birds is prohibited throughout the County Borough of Barrow-in-Furness:—

Blackbird, Goldfinch, Kingfisher, Lark, Linnets, Robin, Thrush, Wren, Golden-crested Wren.

*All Birds Protected on Sundays and on Christmas Day throughout the County Borough.*

V. During those periods of the year to which the protection afforded by the Wild Birds Protection Act, 1880, as extended by Clause II of this Order, does not apply, the killing or taking of Wild Birds on Sundays and on Christmas Day is prohibited throughout the County Borough of Barrow-in-Furness.

**EGGS.**

*All Eggs Protected within a certain Area.*

VI. The taking or destroying of the eggs of any species of Wild Birds is prohibited within that part of the County Borough of Barrow-in-

Furness known as the Island of Walney for a period of five years from the date of this Order.

*Certain Eggs Protected throughout the County Borough.*

VII. The taking or destroying of the eggs of the following species of Wild Birds is prohibited throughout the County Borough of Barrow-in-Furness:—

Blackbird, Chaffinch, Curlew, Dipper, Stock Dove, Wild Duck, Goldfinch, Black-headed Gull, Pied Flycatcher, Heron, Kestrel, Kingfisher, Moorhen, Nightjar (Goat Sucker, Night Hawk, or Fern Owl), Owl, Oyster Catcher, Ringed Plover, Redshank, Robin, Sandpiper, Sheldrake, Snipe, Teal, Tern, Thrush, Long-tailed Tit, Wheatear, Whitethroat, Lesser Whitethroat, Woodcock, Golden-crested Wren.

*Repeal of former Order.*

VIII. The Order of the 30th January, 1913, is hereby repealed.
