The KING has been pleased, by Letters Patent under the Great Seal of the United Kingdom of Great Britain and Ireland, bearing date the 3rd May, 1913, to declare that Mary Frances Katherine Petre, commonly called the Honourable Mary Frances Katherine Petre, only child and sole heir of Bernard Henry Philip, fourteenth Baron Petre of Writtle, in the county of Essex, deceased, is and shall be Baroness Furnivall: And to give, grant and confirm the Barony of Furnivall, which fell into abeyance on the death of Edward, Duke of Norfolk, in the year one thousand seven hundred and seventy-seven, to the said Mary Frances Katherine Petre: To have and to hold the said Barony, together with all the rights, privileges, pre-eminences, immunities and advantages, and the place and precedence due and belonging thereto, to her and to the heirs of her body lawfully begotten and to be begotten, in as full and ample a manner as the said Edward, Duke of Norfolk, or any of his ancestors, held and enjoyed the same.

**NILE STREET INDUSTRIAL SCHOOL
FOR GIRLS, LIVERPOOL.**

Certificate for the premises No. 23, Alfred Street, Liverpool.

- (a) As a part of the Nile Street School.
 (b) As an Auxiliary Home in connection with the School.

The Secretary of State for the Home Department has issued a certificate under the provisions of the Children Act, 1908 (8 Edw. VII, cap. 67), for the premises No. 23, Alfred Street, Liverpool, as an outlying part of the Nile Street Girls' Industrial School, Liverpool, and also as an Auxiliary Home in connection with the said School.

The certificate provides that the number of girls resident at any one time in the said premises, No. 23, Alfred Street, Liverpool, shall not exceed 17, of whom not more than 10 shall be girls under detention at the Nile Street School, and not more than 7 shall be girls who have left the School and are received into these premises-as being an Auxiliary Home.

The certificate bears date the 19th May, 1913.
