### MOTOR CAR ACT, 1903.

#### COUNTY OF SURREY.

Whereas by sub-section (1) of section 9 of the Motor Car Act, 1903, it is enacted that within any limits or place referred to in regulations made by the Local Government Board with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed exceeding ten miles per hour;

And whereas the County Council of Surrey have made an application to the Local Government Board for a regulation to be made in pursuance of the said sub-section putting the above-mentioned provisions of that sub-section in force within the limits comprising the following parts of roads within the Parish of Oxted, in the Rural District of Godstone, that is to say:—

So much of the road through the village of Oxted as extends from a point 100 yards west of its junction with Brook Hill to its junction with Station Road;

So much of Brook Hill as extends for a distance of 150 yards from its junction with the road through the village of Oxted; and

So much of Beadle's Lane as extends for a distance of 150 yards from its junction with the road through the village of Oxted.

And whereas notice of the said application and of the time and manner in which objections should be made to any such regulation appeared in the London Gazette of the 8th day of December, 1911, and in the Surrey Mirror and County Post of the 8th day of December, 1911.

And whereas certain objections to the making of any regulation in pursuance of the said provisions have been received by the Local Government Board, and it is expedient that further inquiry should be made in the matter of the said application:

Notice is hereby given, that R. C. Maxwell, Esquire, Barrister-at-Law, one of the Inspectors of the Local Government Board, will attend at the Church Room, Oxted, on Friday, the fourth day of July, 1913, at a quarter-past three o'clock in the afternoon, to hold a Local Inquiry into the subject-matter of the said application.

And notice is hereby further given, that any person interested may attend at such Inquiry and be heard with reference to the said application.

### ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 19TH JUNE 1913.)

### KEIGHLEY ALLOTMENT GARDENS (SWINE-FEVER) ORDER OF 1913.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1911, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:—

#### *Premises to which this Order applies.*

1.—(1.) This Order shall apply to the premises described in the schedule hereto, and also to any other premises in the borough of Keighley to which the Order may be applied by a Notice to that effect signed by an Inspector of the Board or of the Local Authority of the said borough and served upon the occupier of the premises described in such Notice.

(2.) This Order shall cease to apply to any premises upon service on the occupier thereof of a Notice to that effect signed by an Inspector of the Board.

(3.) A copy of every Notice served under this Article shall forthwith be sent to the Board by the Inspector signing the same.

#### *Restrictions on Movement of Swine from or to Premises to which this Order applies.*

2. Swine shall not, except as expressly authorised by this Order, be moved from or to any premises to which this Order applies.

#### *Movement of Swine for Immediate Slaughter.*

3.—(1.) Swine (not being in a Swine-Fever Infected Place and their movement not being prohibited by Notice of an Inspector of the Local Authority or of the Board given under any Order of the Board) may be moved from any premises to which this Order applies to a slaughter-house situate in the borough of Keighley for the purpose of immediate slaughter if accompanied by a licence in the Form D set forth in the First Schedule to the Swine-Fever (Regulation of Movement) Order of 1908 authorising such movement, granted by an Inspector of the Local Authority of the said borough, which licence shall be in force for not more than eight days inclusive of the day of issue.

(2.) Before a licence is granted by an Inspector under this Article the owner of the swine, or his agent authorised in writing for this purpose, shall sign, and deliver or send by post to the Inspector, a declaration in the Form E set forth in the First Schedule to the Swine-Fever (Regulation of Movement) Order of 1908, which shall be retained by the Inspector.

(3.) The swine shall, before the movement is commenced, be marked by and at the
