SPECIAL REGULATIONS RESPECTING AN OPEN COMPETITIVE EXAMINATION FOR SITUATIONS AS ASSISTANT CLERK (ABSTRACTOR CLASS) IN DEPARTMENTS OF THE CIVIL SERVICE. (Supplementary to the General Regulations respecting Open Competitive Examinations for Situations in the Civil Service, included in Schedule A of the Order in Council of 10th January, 1910.)

- The limits of age for this Examination are 17 and 18, and Candidates must be of the prescribed age on the 1st November, 1913: extension of age is allowed on account of previous public service.
- 2. The Examination will be in the following subjects:-
  - 1. English Composition (including Handwriting and Spelling).
    - 2. Arithmetic.
    - Digesting Returns into Summaries.
      Précis and Indexing.

    - 5. Book-keeping or Shorthand.

Candidates who fail to obtain such an aggregate of marks as may indicate in the judgment of the Civil Service Commissioners a competent amount of general proficiency will not be regarded as qualified.

- 3. Application for permission to attend the Examination must be made at such time and in such manner as the Commissioners may appoint.
- 4. It will rest with the Civil Service Commissioners to determine the Departments to which the successful Candidates shall be assigned.
