dary which divides the said parish of Woodhall from a detached portion of the said parish of Thimbleby) for a distance of one mile and thirty-four chains or thereabouts to the point where the boundaries of the said parish of Woodhall, of another detached portion of the said parish of Thimbleby, and of the said new parish of Saint Andrew, Langton, all meet.

"II. And also all those contiguous portions of the parish of Edlington, in the said county and diocese, and of the said parish of Thimbleby, which, taken together, are bounded upon the north-west by the parish of Stixwould, in the said county and diocese, upon the south-west by the parish of Martin-in-Timberland, in the said county and diocese, upon the south-east and upon the east by the said new parish of Saint Andrew, Langton, and upon the north by an imaginary line commencing upon the boundary which divides the said new parish of Saint Andrew, Langton, from the said parish of Edlington at the point in the middle of the stream known as Monk's Drain, where such stream turns westward and passes underneath the Horsington Road, and extending thence westward along the middle of Monk's Drain for a distance of twelve chains and a half or thereabouts to the boundary which divides the said parish of Edlington from the said parish of Stixwould."

And whereas drafts of the said scheme or representation have been transmitted to the patrons and to the Incumbents of the cures affected by the arrangements which are contemplated by such scheme or representation, and such patrons and Incumbents have respectively signified their assent thereto.

And whereas the said scheme or representation has been approved by His Majesty in Council:

Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme or representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts. And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said Diocese of Lincoln.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Act of the sixth and seventh years of His late Majesty King William the Fourth, chapter seventy-seven; of the Act of the seventh and eighth years of Her late Majesty Queen Victoria, chapter ninety-four; of the Act of the thirteenth and fourteenth years of Her said late Majesty, chapter ninety-four; and of the Act of the thirty-second and thirty-

third years of Her said late Majesty, chapter ninety-four, duly prepared and laid before His Majesty in Council a Scheme or Representation, bearing date the thirty-first day of July, in the year one thousand nine hundred and thirteen, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the sixth and seventh years of His late Majesty King William the Fourth, chapter seventy-seven, the Act of the seventh and eighth years of Her late Majesty Queen Victoria, chapter ninety-four, the Act of the thirteenth and fourteenth years of Her said late Majesty, chapter ninety-four, and the Act of the thirty-second and thirty-third years of Her said late Majesty, chapter ninety-four, have prepared, and now humbly lay before Your Majesty in Council the following Scheme or Representation for altering the boundaries of the new parish of Christ Church, Catshill, in the county of Worcester, and in the diocese of Worcester, the new parish of The Lickey, in the said county of Worcester, and in the diocese of Birmingham, and the new parish of All Saints, Bromsgrove, in the said county of Worcester.

"Whereas by the authority of an Order of Her said late Majesty in Council, bearing date the second day of October, in the year one thousand eight hundred and forty-three, and published in the London Gazette on the twenty-third day of January in the following year, a certain part of the parish of Bromsgrove, in the said county of Worcester, and in the said diocese of Worcester, was assigned as a chapelry district to the consecrated church called Christ Church, situate at Catshill, in the said parish of Bromsgrove, and the said chapelry district was named 'The Chapelry District of Christ Church at Catshill.'

"And whereas by the authority of another Order of Her said late Majesty in Council, bearing date the thirty-first day of July, in the year one thousand eight hundred and fifty-eight, and published in the London Gazette on the thirteenth day of the following month a consolidated chapelry was assigned to the consecrated church of the Holy Trinity, situate at The Lickey, in the said parish of Bromsgrove, and the said consolidated chapelry was named 'The Consolidated Chapelry of The Lickey.'

"And whereas by the authority of another Order of Her said late Majesty in Council, bearing date the thirteenth day of May, in the year one thousand eight hundred and seventy-five, and published in the London Gazette on the following day, a district chapelry was assigned to the consecrated church of All Saints, situate in the said parish of Bromsgrove, and the said district chapelry was named 'The District Chapelry of All Saints, Bromsgrove.'

"And whereas the said chapelry district of Christ Church at Catshill (commonly called Christ Church, Catshill), the said consolidated chapelry of The Lickey, and the said district chapelry of All Saints, Bromsgrove, have, under the provisions of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter one hundred and four, become new parishes of the character contemplated by that Act, by the Act of the sixth and seventh years of Her said late Majesty, chapter thirty-
