vicarage of the said new parish of Saint Peter, Coventry (in testimony whereof they, the said consenting parties, have respectively signed and sealed this representation), we, the said Ecclesiastical Commissioners for England, humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of the said parish of Stoke, and of the said new parish of Saint Peter, Coventry, which are described in the Schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said Church of Saint Margaret, Coventry, situate as aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint Margaret, Coventry.'

"We, therefore, humbly pray that Your-Majesty will be graciously pleased to take the premises into Your Royal consideration, and to make such Order in respect thereto as to Your Majesty in Your Royal Wisdom shall seem meet.

## "The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Margaret, Coventry, comprising:----

"I. All that portion of the parish of Stoke, in the county of Warwick and in the diocese of Worcester, which is bounded upon part of the east by the parish of Wyken, upon the north partly by the last-named parish, partly by the parish of Foleshill, and partly by the new parish of Saint Paul, Foleshill, upon the west partly by the new parish of Saint Mark, Coventry, partly by the new parish (sometime chapelry district) of Saint Peter, Coventry, and partly by the new parish of All Saints, Coventry, all in the said county and diocese, upon part of the south by the said new parish of All Saints, Coventry, and upon the remaining sides, that is to say, upon the remaining part of the south and upon the remaining part of the east, by an imaginary line commencing at the point upon the northern side of Binley Road where the boundaries of the said new parish of All Saints, Coventry, of the parish of Saint Michael, Coventry, in the said county and diocese, and of the said parish of Stoke all meet, and extending thence eastward along the northern side of Binley Road for a distance of two chains and a half or thereabouts to the point where it meets the wall or fence forming the western boundary of Stoke Park, and extending thence first northward, then eastward, and then again northward along such wall or fence for a distance of thirteen chains and a half or thereabouts to its northern end, where it meets the wall or fence forming the northern boundary of the said park, and extending thence eastward along the last-mentioned wall or fence for a distance of thirteen chains and a quarter or thereabouts to its eastern end on the western side of Brays Lane, and extending thence first eastward to, and then first northward, and then north-westward along the middle of Brays Lane for a distance of sixteen chains and a half or thereabouts to its junction with Walsgrave Road and Clay Lane, and extending thence first northward and then eastward, along the middle of Clay Lane for a distance of twenty-seven chains and a half or

thereabouts to its junction with Coventry Street, and extending thence first northward and then eastward clong the middle of Coventry Street, for a distance of six chains or thereabouts to the point where such street crosses the municipal boundary of the city of Coventry, and extending thence northward along such boundary for a distance of eleven chains or thereabouts to the point where it joins the boundary which divides the said parish of Stoke from the said parish of Wyken.

"II. And also all that contiguous portion of the said new parish of Saint Peter, Coventry, which is bounded upon the east by the above-described portion of the said parish of Stoke, upon the south-east and upon the west by the said new parish of All Saints, Coventry, and upon the remaining sides, that is to say, upon the north-west and upon the north, by an imaginary line commencing upon the boundary which divides the said new parish of All Saints, Coventry, from the said new parish of Saint Peter, Coventry, at the junction of Paynes Lane with Britannia Street, and extending thence eastward along the middle of Britannia Street for a distance of four chains and a quarter or thereabouts to its junction with Wren Street, and extending thence first northward and then eastward along the middle of Wren Street for a distance of seven chains or thereabouts to a point opposite to the south-western corner of the Coventry City Football Ground, and extending thence first northward to and then eastward along the wall or fence forming the southern boundary of the said Football Ground for a distance of seven chains and a half or thereabouts to its eastern end upon the western side of Swan Lane, and extending thence in a straight line due east across Swan Lane to the boundary which divides the said new parish of Saint Peter, Coventry, from the said parish of Stoke."

And whereas the said representation has been approved by His Majesty in Council:

Now, therefore, His Majesty; by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts. And His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Worcester.
