MOTOR CAR ACT, 1903. Regulations under Section 9 (1). COUNTY OF SURREY.

Parish of Oxted.

To the County Council of Surrey; And to all others whom it may concern.

WHEREAS by sub-section (1) of section 9 of the Motor Car Act, 1903 (hereinafter referred to as "the Act"), it is enacted that, within any limits or place referred to in regulations made by Us, the Local Government Board, with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed

exceeding ten miles per hour;
And whereas the County Council of Surrey, having made application to Us to make a regulation in pursuance of the said sub-section putting the above-mentioned provisions of that sub-section in force within the limits comprising parts of certain roads in the Parish of Oxted, We directed a Local Inquiry to be held into the matter by one of Our Inspectors, and the Inquiry was held accordingly, and Report has been made to Us thereon:

NOW THEREFORE, in pursuance of the powers given to Us in that behalf, We do, by this Our Order, make the following Regula-

ARTICLE I.—The provisions of sub-section (1) of section 9 of the Act with respect to the driving of a motor car at a speed not exceeding ten miles per hour shall apply and have effect. within the limits comprising the parts of roads within the Parish of Oxted which are specified! in the Schedule hereto.

ARTICLE II.—These Regulations shall comeinto operation on the twentieth day of October, one thousand nine hundred and

## SCHEDULE.

So much of the road through the village of Oxted as extends from a point 100 yards west of its junction with Brook Hill to its junction with Station Road;

So much of Brook Hill as extends for a distance of 150 yards from its junction with the road through the village of Oxted; and

So much of Beadle's Lane as extends for a distance of 150 yards from its junction with the road through the village of Oxted.
