The following Statute, made by the Governing Body of Balliol College, Oxford, on the 9th day of October, 1913, and sealed on the 29th day of January, 1914, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1877" :—

STATUTE made at a General Meeting of the Governing Body of Balliol College, Oxford, specially summoned for that purpose and held on the 9th day of October, 1913, and passed by the unanimous vote of those present :—

(i) In Statute III, 16 (d), for "Provided that College walls" substitute "Provided that at least four persons, engaged in the educational work of the College, exclusive of the Master, three of whom shall be unmarried, shall reside within the College walls. Nothing in this clause shall preclude the re-election of a Tutorial Fellow at the expiry of any of his periods of service."

(ii) In Statute III, 16 (e), for "So long College Terms" substitute "So long as there are four persons, exclusive of the Master, three of them being unmarried, engaged in the educational work of the College, and resident within the College walls, during the usual College Terms."
