

from the day of his election. Every Official Fellow shall reside in the College during the usual College Terms, unless the President and Fellows at a Stated General Meeting have given him leave to reside elsewhere; and there shall always be at least four Official Fellows resident in rooms in the College during the usual College Terms. So long as that number is complete, an Official Fellow vacating his Fellowship by marriage shall not be incapable of being elected to fill the vacancy so created if the College should desire to retain his services as a Tutor, Lecturer, or Bursar, and provided that he undertakes, if required, to reside in rooms in the College during the usual College Terms for so many Terms as may be prescribed by the President and Fellows. For the purposes of this clause a Fellow in Holy Orders elected under the following clause shall be deemed an Official Fellow.

The President and Fellows may by a majority of those present and voting at a General Meeting specially summoned for the purpose grant to an Official Fellow in case of serious but temporary illness, or for such other special reason as may in their judgment be sufficient, a dispensation from residence for a period not exceeding one Term, which dispensation may be renewed for a second and a third Term under the same conditions. An Official Fellow dispensed from residence under this clause shall be entitled to the emoluments of his Fellowship only, and not to any part of the stipend of any College office; but he may receive a special grant from the Tuition Fund, and he may be allowed to count the period of such non-residence towards his service for a pension under Statute VI.

The President and Fellows may by a majority of not less than two-thirds of those present and voting at any Stated General Meeting grant to an Official Fellow, who has made application in writing not less than sixty days previously, a dispensation from residence for the purpose of travel or study or some similar object, for a period not exceeding two Terms in every seven years of his service as Tutor, Lecturer, or Bursar, or (alternatively) three Terms in every ten years of such service. An Official Fellow dispensed from residence under this clause shall be entitled to the emoluments of his Fellowship, but not to rooms in College, nor to any part of the stipend of any College office, nor to any payment from the Tuition Fund. The period of such dispensation from residence shall count towards service for a pension under Statute VI to the extent of not more than three in all of the usual College Terms.

The following Statute, made by the Governing Body of Trinity College, Oxford, on the 9th day of December, 1913, and sealed on the 9th day of February, 1914, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is

published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1877."

At a meeting of the Governing Body of Trinity College, Oxford, specially called for the purpose, with due notice of the business to be transacted thereat, held on Tuesday, December 9th, 1913, it was resolved by a majority of two-thirds of those present and voting, to make the following addition to the Statute of the College concerning the scholars and exhibitioners, and to affix the College seal to it:—

After clause 12 of Statute III add the following new clause:—

13. The President and Fellows may establish and maintain from time to time not more than four Senior Scholarships, open to members of the University of Oxford, for the encouragement and assistance of men who desire, after graduation, to pursue some course of special study, or to undertake some definite work of research, or to enter upon a course of higher professional training with a view to their future career, and who are in need of help for such purposes, either by suspending one of the twelve Fellowships or by devoting to this object any sums which by Statute III, clause 9, may be paid annually out of the Corporate Revenue into the Exhibition Fund. The other conditions of eligibility for such Senior Scholarships, the method of award, the annual value, the period of tenure, and the nature of the study required shall be determined by regulations, which shall be prescribed in the first instance, and may be varied from time to time, by a majority of not less than two-thirds of the persons present and voting at a General Meeting specially summoned for the purpose.

The following Statute made by the Governing Body of Brasenose College, Oxford, on the 18th day of February, 1914, has been submitted for the approval of His Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of "The Universities of Oxford and Cambridge Act, 1877":—

At a meeting of the Principal and Fellows of Brasenose College, held on 18th February, 1914, it was resolved by a majority consisting of not less than two-thirds of the number of persons present and voting on the question, pursuant to the provisions of the Universities of Oxford and Cambridge Act, 1877, and Statute XIX of the College Statutes, to make the following alterations of Statute, to wit:
