## PORTSLADE INDUSTRIAL SCHOOL. New Certificate.

The Portslade Industrial School for Boys, originally certified on the 3rd May, 1902, on the application of a Joint Committee of the London and Brighton School Boards, then the Managers of the School, having been taken over from the aforesaid Joint Committee by the London County Council, the Secretary of State for the Home Department has issued a new certificate certifying that the said school is fitted to be an Industrial School for the reception of boys sent thereto in accordance with the provisions of the Children Act, 1908, or of the Elementary Education Act, 1876.

The certificate, which bears date the 9th March, 1914, provides that the number of boys resident in the school at any one time, whether sent thereto in pursuance of the said Acts or otherwise, shall not exceed 120.
