The KING has been pleased, by Warrant under His Majesty's Royal Sign Manual, bearing date the 28th ultimo, to appoint the Reverend George Russell Gipps, B.A., to the living of Saint Anne, Hoxton, in the county of Middlesex and diocese of London, void by the resignation of the Reverend William Michael Puttock, the last Incumbent.
