MOTOR CAR ACT, 1903. Regulations under Section 9 (1). COUNTY OF BUCKINGHAM.

CHESHAM.

To the County Council of Buckingham ;-And to all others whom it may concern.

WHEREAS by sub-section (1) of section 9 of the Motor Car Act, 1903 (hereinafter referred to as "the Act"), it is enacted that, within any limits or place referred to in Regulations made by Us, the Local Government Board, with a view to the safety of the public, on the application of the local authority of the area in which the limits or place are situate, a person shall not drive a motor car at a speed

exceeding ten miles per hour;
And whereas the County Council of Buckingham, having made application to Us to make a Regulation in pursuance of the said sub-section putting the above-mentioned pro-visions of that sub-section in force within the limits comprising certain roads or parts of roads within the Urban District of Chesham, We directed a Local Inquiry to be held into the matter by one of Our Inspectors, and the Inquiry was held accordingly, and Report has been made to Us thereon:

NOW THEREFORE, in pursuance of the powers given to Us in that behalf, We do, by
