The Board of Trade have received, through the Secretary of State for Foreign Affairs, a copy of a Telegram, dated the 31st December, from His Majesty's Ambassador at Athens, stating that the following sanitary measures have been imposed on arrivals from Chios and Mitylene:—

Medical inspection at first port in Greece. Medical inspection of passengers and crew before departure from those islands. Deratisation every 10 days of ships which have been in contact with shore. Ships unprovided with certificates of Sanitary Officers of those islands will be sent on to a Greek port for deratisation.
