##### NATIONAL HEALTH INSURANCE.

The National Health Insurance (Wales) (Deposit Contributors, Adjustment of Accounts) Order, 1914, dated December 31, 1914, made by the Welsh Insurance Commissioners under Sections 78 and 82 of the National Insurance Act, 1911 (1 & 2 Geo. 5, c. 55).

Whereas by paragraph (e) of Section 42 of the National Insurance Act, 1911 (in this Order called "the Act"), it is provided that the sums payable in respect of a deposit contributor for the purposes of medical and sanatorium benefit and towards the expenses of administration shall be deducted at the commencement of each year from the amount standing to his credit in the Deposit Contributors Fund:

And whereas by sub-section (2) of Section 43 of the Act it is provided that where a deposit contributor becomes a member of an Approved Society, there shall be transferred to the Society the amount standing to his credit in the said Fund, or the value of the contributions paid by or in respect of him, whichever sum shall be the less:

And whereas it will not be practicable to ascertain what amount is standing to the credit of a deposit contributor who becomes a member of an Approved Society as at the date of such transfer, and delay will arise in ascertaining his position in insurance and in the administration of his benefits by his Society:

And whereas under the aforesaid Section 43, where the amount standing to his credit is less than the value of the contributions paid by or in respect of him, it is provided that he
