W HEREAS there was this day read at the Board a Memorial from the Right Honourable the Lords Commissioners of the Admiralty, dated the 21st day of February, 1915, in the words following, viz.:—
"Whereas by Section 3 of the Naval and

Marine Pay and Pensions Act, 1865, it is enacted, inter alia, that all pay, pensions, or other allowances in the nature thereof, payable in respect of services in Your Majesty's Naval or Marine Force to a person being or having been an Officer, Seaman, or Marine therein, shall be paid in such manner, and subject to such restrictions, conditions, and provisions, as are from time to time directed

by Order in Council:

"And whereas by Order in Council, bearing date the 8th day of August, 1911, Your Majesty was pleased to sanction the payment of allowances to Officers actually borne for the performance of Engineering Duties, subject to their having passed certain courses in En-

"And whereas these courses have been suspended during the present state of hostilities, and it is therefore necessary to make provision for the performance of Engineering Duties by Officers who may not have passed the specified courses, but who should nevertheless be eligible

to receive the authorized allowances:
"We beg leave humbly to recommend that Your Majesty may be graciously pleased, by Your Order in Council, to sanction the pay-ment during the period of hostilities of the allowances authorized for the performance of Engineering Duties to such Officers, subject to such conditions as regards practical training as we may deem necessary. "The Lords Comm

Commissioners of Your Majesty's Treasury have signified their concurrence in this proposal."

Majesty, having ${f taken}$ the said Memorial into consideration, was pleased, by and with the advice of His Privy Council, to approve of what is therein proposed. And the Right Honourable the Lords Commissioners of the Admiralty are to give the necessary directions herein accordingly.

Now, therefore, His Majesty is pleased, by and with the advice of His Privy Council, to re-appoint Professor Arthur Schuster, F.R.S., and William Cawthorne Unwin, Esquire, LL.D., F.R.S., to be members of the Senate of the said University of London.

WHEREAS the territories of Africa known as the East Africa Protectorate are under the protection of His Majesty the King:

And whereas by treaty, grant, usage, sufferance, and other lawful means, His Majesty has power and jurisdiction within the said Protectorate:

And whereas by an Order of His late Majesty in Council, bearing date the 11th day of August, 1902, and entitled "The East Africa Order in Council, 1902," provision was made for the administration of the Government of the said Protectorate by a Commissioner:

And whereas by a further Order of His late Majesty in Council, bearing date the 22nd day of October, 1906, and entitled "The East Africa Order in Council, 1906," it was provided that a Governor should be appointed for the said Protectorate in place of a Commissioner :

And whereas by the Fifteenth and Sixteenth Articles of the last-recited Order provision was made for the administration of the Government of the said Protectorate in the absence of the Governor:

And whereas by a further Order of His late Majesty in Council, bearing date the 2nd day of November, 1907, and entitled "The East Africa Order in Council, 1907," fresh Articles were substituted for the Fifteenth and Sixteenth Articles of the last-recited Order:

And whereas it is desirable to make other provision in regard to the appointment of a Deputy by the Governor during his temporary absence:

Now, therefore, His Majesty, by virtue and in exercise of the powers on that behalf by the Foreign Jurisdiction Act, 1890, or otherwise, in His Majesty vested, is pleased, by and with the advice of His Privy Council, to order, and it is hereby ordered, as follows:—

I. This Order may be cited as "The East

Africa Order in Council, 1915."

II. The Article which was substituted by the above-recited Order in Council of the 2nd day of November, 1907, for the aforesaid Sixteenth Article of the above-recited Order in Council of the 22nd day of October, 1906, is, as from the coming into operation of this Order, hereby revoked without prejudice to
